- Construction has been ongoing for two years.
- Money spent to date is \$15 million.
- Oxidation ditch three had a disk failure before the 4th of July.
- Oxidation ditch 4 has been running for over a year with no issues.
- Anderson has been on site investigating the failure.

Power Point on new Office Building Options presented by General Manager Dina Breitstein.

- Eight options were listed:
 - Stay in existing building.
 - Leasing rental space.
 - New building on Community Center Property.
 - o New modular building on Community Center Property.
 - o Purchase new property with Office space.
 - o Remodel Community Center.
 - New facility at existing site.
 - o Existing building at Riverlake and DB Blvd.
- Each option listed pros and cons as well as if it were a viable option based on requirements and needs.

Public Comment:

- 1. First speaker opposed renting. He feels purchasing new land or using existing land is preferred.
- 2. Second speaker inquired on the location of the office space available for purchase. He also asked about the cost to retrofit the rental spaces.
- The first speaker returned to the podium to state that he feels all staff does not need individual office space.
