## D. DISCUSSION ITEMS

1. Discussion Regarding Landscape Update for Parks and Streetscapes.

Parks and Landscape Manager, Bill Engelman provided update on landscape maintenance he and the landscape team have been focusing on. He also expressed interest in beginning several heavier landscaping projects throughout the Town. He would like to construct a strategy to redesign Discovery Bay streets. Primarily, Parks and Landscape Manager Engelman would like to construct a layout in a quiet area to introduce a model for other locations.

Chair Graves expressed support and interest in finding an appropriate location for any model. He also

expressed interest in possibly inviting the public to look at the area proposed for improvement.

Chair Gutow expressed gratitude for hard work and noticeable improvements throughout the Town. Chair Gutow expressed support to proceed with renovations in landscaping improvements.

Town General Manager requested an update of cost and projected expense to present to the Board as part of the planning process.

Chair Graves spoke of the possibility to use Hoffman funds for Zone 8 landscaping enhancements.

2. Discussion Regarding Park & Recreation Update.

Town General Manager, Mike Davies gave an update on the continued closure of some parks. Recreation Programs Supervisor, Monica Gallo provided an update on how social distancing has affected recreational activities. Some whom had signed up for classes at the Community Center have been issued credit vouchers for future classes or have provided refunds. Also, an update was given on slight easing of social distancing regulations at parks. Recreation Programs Supervisor Gallo stated that although social distancing guidelines have become marginally modified, some activities continue to be discouraged. A list of allowed activities with gathering modifications was addressed.
