E. DISCUSSION ITEMS

1. Discussion Regarding Chair and Vice-Chair.

General Manager Davies – Provided the details regarding the Chair and Vice-Chair. The decision will be for the 2019 year Chair Robert Leete and Vice-Chair Bill Mayer.

2. Discussion Regarding Community Center Pool Financing.

General Manager Davies – Provided a background regarding the site assessment and geotechnical survey from Terracon and reviewed the options with the Parks and Recreation Committee; Parks and Recreation Committee's recommendation is to consider option 3. There was discussion regarding the ADA requirements. Finance Manager Breitstein – Provided the details of 6 funding scenarios;

- 1. Continue with the Community Center Pool Refurbishment.
- 2. Build new pool (reutilize option 3 for the scenarios) finance with the Hofmann money and Wastewater Loan.
- **3.** Build new pool (option 3) finance with Hoffmann money, Community Center Reserve and Wastewater Loan 2 year payback.
- **4.** Build new pool (option 3) finance with Hoffmann money, Community Center Reserve and Wastewater Loan 4 year payback.
- 5. Build new pool (option 3) finance with Hofmann money and Commercial Loan.
- 6. Build new pool (option 3) finance with Hoffmann money, Community Center Reserve and Commercial Loan 4 year payback.

There was discussion regarding the scenarios, items to consider with borrowing from Wastewater, interest payback (check with Auditors), and Hofmann money (Zone 8).

Public Comment Regarding:

- Times for Committee meetings and consideration of repair of existing pool (larger pool seems to be the decision made by the committees).
- Revenue for a larger pool that will pay for maintenance and cleaning.
- Generating income from a larger pool (events), Community Center building improvements.
- Lion's Club donating money, River Otters fund raising, renting out the pool for other activities.
- ADA compliance; bathroom facilities.
- Improvements to other recreational activities.
- Minimum pool upgrade for safety and other activities; water polo and scuba diving.

There was discussion regarding the options; finance options (possibly increase the number of years to payback).

Review longer paybacks and review other activities for the community. If the Board decides to move forward with the pool the recommendation is option 3. The decision comes from the Board (either fill with dirt, refurbish the pool or to go with any of the 3 options).

The discussion continued regarding the pool cost, RFP, design, and the possibility of an increase in the pool bids/cost.

General Manager Davies – Provided the details regarding the Programming Assumptions and impact on cost (staffing levels, operating costs, additional activities, and maintenance on the pool).

Public Comment Regarding:

• Special Interest cost/groups, year round use of the pool, maintenance of the pool and volume of the pool.

General Manager Davies - Thanked staff for the work done on this project. Direction to Staff:

- Pool estimated cost to fill the hole.
- Go back to the original plan rebuilding the existing pool.
- Scenario for extended payback financing.

The discussion continued that the pool project should be well considered. The items will be brought back to a Special Finance Committee meeting.
