Those changes are included and referenced in the proposed Code, as attached.

The Fair Political Practices Commission (FPPC) has adopted the California Code of Regulations, Title 2, §18730, which outlines the terms of a standard Conflict of Interest Code that can be adopted by reference. The District's Code includes this reference. Each year, the Board as well as certain members of the staff are required by the FPPC to file a Form 700. Government Code §87203 is the legislative section that Form 700 is derived. Consequently, it is recommended that the District's Code include this reference (Government Code §87203) in order that the Code is consistent with Form 700. This action ties the two (2) conflict of interest requirements together.

Executive Summary

On Friday, October 12, 2012 Staff was notified by the Contra Costa County Sheriff's Department about a series of vandalisms that occurred the previous night. Cornell Park's entry sign was damaged as a result of these vandalisms (Photo #1).

Staff has researched the cost of replacing this sign with one (1) of the concrete monument signs that mark all other parks in Discovery Bay (Photo #2). These types of signs are more vandal resistant and have a longer life expectancy than the wooden sign that originally was installed at Cornell.

Quick Crete Products is the manufacturer of the specified monument sign that matches the other Discovery Bay parks. They have provided a quote in the amount of \$4,480.47, which included the monument, new town logo, delivery and offload/placement. The concrete pad and preparation is not included, but is not expected to exceed \$1,200.00.

Staff recommends accepting the proposal from Quick Crete Products in the amount of \$4,480.47 and authorizing Staff to contract for installation, with a total combined project cost not to exceed \$5,700.00. Total project cost would be pulled from Zone 8 reserve account and shown on a future budget amendment.

Executive Summary

On October 3, 2012 the Board adopted Resolution 2012-23 amending Capacity Charge Fee Program. It was noted after that adoption that there were capacity fees that had not been incorporated into the study and were not a part of the adopting resolution. The change results in improvements that were initiated by the Town of Discovery Bay and that took place *after* the Hofmann Land Development Company constructed their initial facilities. In the table below, the fees have been updated and correctly identify those fees that were established in Resolution 2004-03 that addresses those improvements. Once the Hofmann Land Development Company hits the different levels of EDU counts, the original fees are then incorporated into the new fees identified in the Final Bartle Wells Associates Technical Memorandum dated October 15, 2012, and attached.

The breakdown of that committed capacity is as follows (changes are underlined, below):

TECHNICAL MEMORANDUM

Introduction

The Town of Discovery Bay Community Services District ("Town") provides water supply, treatment, and delivery as well as wastewater collection, treatment, and disposal to approximately 14,000 residents. The Town recently completed master plans that determined the level of growth for the community through FY2021 and identified needed facility improvements. Some improvements are needed to correct deficiencies in existing facilities and other improvements are needed to expand capacity to serve future development.

This Technical Memorandum was developed with the goal of fairly assigning the cost of improvements to existing and future customers and to calculate capacity fees that recover these costs.

Existing and Future Connections

As a first step in this analysis, the existing capacity of water and wastewater facilities was reviewed. The Water Master Plan by Luhdorff & Scalmanini Consulting Engineers, January 2012 ("Water Master Plan") determined that existing average day demand on the system is 3.66 million gallons per day (mgd). The Hofmann Land Development Company ("Hofmann") is owed 0.15 mgd in committed water capacity per a Service Agreement and contractual arrangement with the Town. In total, existing demand and committed capacity sum to about 3.81 mgd. For the purpose of this analysis, committed capacity in both the water and wastewater facilities is treated as existing demand. Through FY2021, water demand is expected to grow by 0.66 mgd.

Existing flow of the wastewater system is 1.80 mgd with 0.21 in additional capacity committed to Hofmann. The wastewater system is expected to grow by 0.41 mgd through FY2021 as described in the Wastewater Treatment Plant Master Plan by Stantec Consulting Services Inc., October 2011, and in the Wastewater Master Plan Addendum ("Wastewater Master Plan").

The master plans identify the typical water demand of a residential customer as about 533 gallons per day and the typical wastewater flow of a residential customer as about 335 gallons per day. This demand and flow is used to determine the number of equivalent dwelling units (EDUs) of the Town.

Table 1 summarizes the existing, committed, and build-out water demand and wastewater flows of the Town.

Buy-in

New customers connecting to the system receive benefit from a large portion of the facilities that are already in place throughout the Town. The buy-in portion of the capacity fee recovers the costs of existing facilities that benefit all customers, existing and new.

The value of existing facilities was calculated using the Replacement Cost New Less Depreciation (RCNLD) method. The book cost of Town facilities less depreciation was escalated to present worth using the Engineering News Record's Construction Cost Index. The RCNLD of facilities is divided by the number of EDUs at build-out to yield a buy-in fee per EDU, see Table 2. A detailed list of Town facilities is shown in Appendix A.

Expansion/Improvements

New customers connecting to the system will also benefit from a number of planned improvements described in the master plans. In consultation with staff, the Town's capital improvement projects were allocated to existing/committed connections and future connections based on how each customer group benefits from the projects. Some projects are expansion related and will not be needed if growth does not occur. Expansion projects are wholly allocated to new connections. Other projects, such as fire flow improvements, benefit all customers, and are allocated based on the total flow or demand of the system at build-out, see Table 3 and Table 4. BWA conducted a preliminary allocation between existing and future customers. The allocations were reviewed in detail by staff and by developer representatives over the course of several meetings and conference calls.

The total cost allocated to future connections is then divided by expected growth in demand or flow to calculate the expansion fee, see Table 5 and Table 6.

Tables 7 and 8 show the total capacity fees for water and wastewater, respectively, which include both a buy-in portion and an expansion portion. Shown in the tables are the residential capacity fees calculated on an EDU basis and example nonresidential capacity fees based on 1,000 gal/day demand or 1,000 gal/day flow.

The total recommended capacity fee per residential connection is calculated at \$13,760, see Table 9. This fee is comparable to the fee charged by local cities, see Table 10.

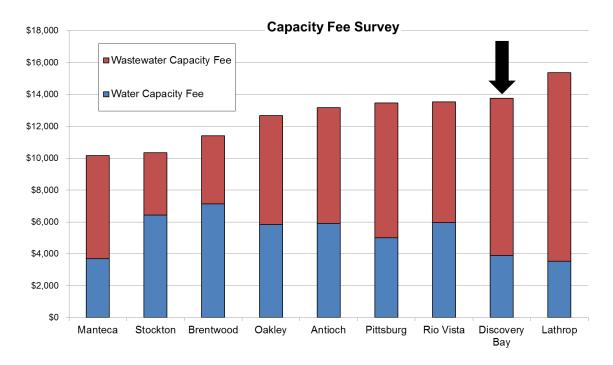

The nonresidential capacity fees are proportional to the water demand and wastewater flow of a typical residential customer. When a new nonresidential customer connects to the system, the Town should scale the capacity fees to the predicted demand and flow of that customer with a minimum fee based on 200 gallons per day water use and 180 gallons per day wastewater flow. The minimum capacity fee is about 49% of the residential capacity fee. Example capacity fees for nonresidential customers are shown in Table 11. For the typical nonresidential customer about 90% of water used flows into the sewer. Commercial customers typically have little to no outdoor irrigation.

Implementation

Capacity fees are collected at the time of connection to the Town's water system and sewer collection system. To ensure continued adequate implementation of the fee, the Town should:

- Maintain an annual Capital Improvement Program budget to indicate where fees are being expended to accommodate growth.
- Comply with the annual and five-year reporting requirements of Government Code 66000 et seq.
- Annually adjust capacity fees using an appropriate construction cost index. Capacity fees should be adjusted regularly to prevent them from falling behind the costs of constructing new facilities. The Engineering News Record magazine publishes Construction Cost Indices (CCIs) monthly for 20 major U.S. cities including San Francisco and an average of 20 cities around the U.S. These indices can be used to estimate the change in the construction cost of facilities, and the Town's capacity fees should be adjusted annually by the change in the ENR CCI for San Francisco.

Credit for Committed Capacity

The capacity fee shown in Table 9 is a general fee that fully recoups the Town's cost of facilities for future customers. Hofmann has contributed a number of facilities to the Town and is owed credit for these facilities as described in the Town's Ordinance No. 19, in the Reimbursement Agreement for Discovery Bay West, and contractual arrangements with the Town. The credit owed to Hofmann is in the form of committed capacity/EDUs.

The committed capacity shown in Table 1 is capacity reserved by Hofmann and is treated as existing capacity for the purpose of calculating the capacity fees. BWA's understanding is that Hofmann is obligated to pay \$297 per committed water EDU and \$2,789 per committed wastewater EDU per a contractual agreement with the Town.

At the time of the writing of this memorandum, Hofmann intends to build an estimated 702 homes. Hofmann is owed 284 EDUs of water committed capacity. Therefore, for the first 284 homes built, Hofmann is obligated to pay \$297 per water EDU. For all homes beyond the first 284, Hofmann will exceed its committed water capacity and should pay the water capacity recommended in Table 9.

Hofmann is also owed 621 EDUs of wastewater committed capacity. Therefore, for the first 621 homes built, Hofmann is obligated to pay \$2,789 per wastewater EDU. For all homes beyond the first 621, Hofmann will exceed its committed wastewater capacity and should pay the wastewater capacity fee recommended in Table 9. See Table 12 for a description of the Hofmann credits and capacity fees.

WHEREAS, on October 3, 2012 the Board of Directors of the Town of Discovery Bay adopted Resolution 2012-23 establishing fees for water capacity charges and wastewater capacity charges; and

WHEREAS, after the adoption of Resolution 2012-23 it was determined that there was a need to adjust the fees due to an omission of information relative to those projects that only affect the Hofmann Land Development Company's Discovery Bay West residential development project; and

WHEREAS, for at least fourteen (14) days prior to the public hearing, a copy of the Bartle Wells Associates Final Technical Memorandum dated October 15, 2012 and Public Notice was available for public review at the District Office, 1800 Willow Lake Road, Discovery Bay, CA, and it was posted to the TODB website at www.todb.ca.gov; and

WHEREAS, the TODB embarked and completed a Water Master Plan and a Wastewater Master Plan that identified future development and associated infrastructure improvements; and

WHEREAS, the TODB engaged the services of Bartle Wells Associates to review those master plans and existing assets and develop a comprehensive Capacity Fee Technical Memorandum; and

WHEREAS, that Technical Memorandum has been completed and submitted to the TODB on October 15, 2012 and identifies water capacity fees and wastewater capacity fees; and

WHEREAS, on November 7, 2012 the Board of Directors of the Town of Discovery Bay conducted a duly noticed public hearing to receive and consider public comments on the FY 2012/13 proposed capacity fee charges, as identified in the Bartle Wells Associates Final Technical Memorandum, Dated October 15, 2012 attached hereto and included by reference.

NOW, THEREFORE, THE BOARD OF DIRECTORS OF THE TOWN OF DISCOVERY BAY COMMUNITY SERVICES DISTRICT DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. That Resolution Number 2012-23 adopted on October 3, 2012 be rescinded.

SECTION 2. That the Technical Memorandum prepared by Bartle Wells Associates on behalf of the TODB, and dated October 15, 2012 is included in its entirety as a part of this resolution.

SECTION 3. That Residential Capacity Fees be established as follows:

- (A) Water Capacity Fees are to be established at \$3,900.00 per EDU.
- (B) Wastewater Capacity Fees are to be established at \$9,860.00 per EDU.

SECTION 4. That Residential Capacity Fees be established as follows for the (Hofmann Company's) Discovery Bay West residential development project:

Recommended Action

Conduct Public Hearing and Adopt Resolution No. 2012-23 establishing capacity charges for water and wastewater service pursuant to Government Code §66016

Executive Summary

On January 4, 2012 the Board authorized a contract with Bartle Wells Associates (BWA) to conduct an analysis and make recommendations relative to the Districts Capacity Fee structure. The last time Capacity Fees were adjusted was on February 18, 2004 (Resolution No. 2004-03). At that time, the fees were established at \$297.00 for water service and \$2,789.00 for wastewater service, for a total fee of \$3,086.00. The fees have not been adjusted since that time.

As a parallel component of the facility Master Planning processes, it is important that the District update the fees charged to developers for new construction and what contributions are required to "buy in" to the existing system as well as contribute to those projects that are necessary as a result of new development.

BWA has completed their analysis, and it is thoroughly described in the attached "FINAL DRAFT" Technical Memorandum. However, it should be noted that the capacity fees that are recommended as a result of this study are \$3,900.00 for Water services and \$9,860.00 for Wastewater services, for a total combined Capacity Fee of \$13,760.00.

BWA staff, District staff, and representatives of the Hofmann Company and Pantages Properties participated in the review of the "preliminary draft" as well as this final draft of the study.

It needs to be noted that Hofmann Land Development (HLD) constructed the Newport Water Treatment Plant as well as Wastewater Treatment #2. As a result of that upfront investment, the HLD has "reserved" capacity in both the water treatment and wastewater treatment facilities. The breakdown of that committed capacity is as follows:

Executive Summary

In 2004 the Town of Discovery Bay CSD Board of Directors adopted Resolution No 2004-08 appointing Bank of Agriculture and Commerce as an alternative depository for certain district funds. Resolution No. 2004-08 states that the funds in the alternative depository shall not exceed \$40,000.00 and that no individual payment from that depository shall exceed \$5,000.00.

In 2011 SB 288 (NEGRETE) was approved and signed into law by the Governor changing the preexisting law that had not been adjusted in over fifty (50) years regarding a Community Service District's ability to utilize a revolving fund for day-to-day small transactions. This change in law was incorporated into Government Code §53952 et seq. and provides the authority for an independent special district to provide for the establishment of a revolving fund in an amount not to exceed 110 percent of one-twelfth of the district's adopted budget for that fiscal year. For the current Fiscal Year, that amount is \$763,950 (110% of 1/12 of \$8.334M). Currently, the ECC Bank revolving fund account balance is \$621,000.

Each month the District collects approximately \$30,000.00 from rate payers for water consumption (and occasionally from contributors to the Community Center fund). Those funds are deposited into the District's Bank account at ECC Bank on behalf of the District. The purpose of the revolving fund is for the District to be able to have the flexibility of paying District invoices that are relatively small. However, when the District installed water meters and initiated water billing for a portion of the community, the funds in the ECC Bank account continue to grow.

Presently, the District, by its own action has restricted the amount of the fund at \$40,000.00 and individual disbursements cannot exceed \$5,000.00. The restriction to prohibit the District from having any single transaction exceed \$5,000.00, severely limits the District's ability to conduct its business.

The proposed action will provide the District the flexibility to pay authorized expenditures that exceed \$5,000.00, but not more than \$100,000.00, with certain exceptions. If the Board does authorize a payment in excess of \$100,000.00 from the alternative depository, staff recommends that under each instance the warrant request be presented to the Board as a separate action before the Board at a Regular or Special meeting of the Board.

Disbursement from the revolving fund will continue to operate as it does currently. Individual payments shall continue to be authorized by the Board of Directors at a Regular or Special meeting of the Board. Additionally, the two (2) signature requirement for check signing will continue to remain in place.

The District currently utilizes ECC Bank, A Division of Bank of Agriculture and Commerce Bank as the District's alternative depository. This action reaffirms that relationship.

WHEREAS, the Town of Discovery Bay Community Services District Board of Directors has previously adopted Resolution No. 2004-08 appointing Bank of Agriculture and Commerce as alternative depository for certain district funds, and

WHEREAS, per the adopted Resolution No. 2004-08 funds shall not exceed \$40,000.00 in the depository and individual payments from that depository shall not exceed \$5,000.00; and

WHEREAS, Pursuant to Government Code §53952(b) an independent special district, as defined in Government Code §61000, may by resolution provide for the establishment of a revolving fund in an amount not to exceed 110 percent of one-twelfth of the district's adopted budget for that fiscal year. The fund may be used to pay any authorized expenditures of the independent special district, and

WHEREAS, the District regularly collects funds from rate payers for water consumption or from contributions to the Community Center fund and those funds are deposited in the ECC Bank on behalf of the District; and

WHEREAS, the purpose of the revolving fund is to be able to have the flexibility of paying District invoices that exceed \$5,000, and

WHEREAS, the General Manager, or designee, shall have authority to make disbursements from the revolving fund and is responsible for keeping account of all receipts and disbursements from the fund, and

WHEREAS, the fund is necessary in order to pay down the ECC bank accounts in order to remain within the limits allowed pursuant to Government Code §53952, and

WHEREAS, the maximum amount of the fund shall not exceed 110 percent of one-twelfth of the district's adopted budget for that fiscal year, and

WHEREAS, individual payments from the account shall not exceed \$100,000.00 and all payments of any amount are to be authorized by the Board of Directors with two (2) signatures required.

NOW, THEREFORE, THE BOARD OF DIRECTORS OF THE TOWN OF DISCOVERY BAY COMMUNITY SERVICES DISTRICT DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. Pursuant to Government Code §53952(b) the Town of Discovery Bay provides for a revolving fund in an amount not to exceed 110 percent of one-twelfth of the district's adopted budget for that fiscal year.

SECTION 2. The fund may be used to pay any authorized expenditures of the Town of Discovery Bay.

SECTION 3. The purpose of the revolving fund is to be able to have the flexibility of paying District invoices that exceed \$5,000.00.

SECTION 4. That the General Manager, or designee, shall have authority to make authorized disbursements from the revolving fund and is responsible for keeping account of all receipts and disbursements from the fund.

SECTION 5. Signature requirements for warrants issued from these accounts shall be in accordance with Article VII of the District's Bylaws.

SECTION 6. That any individual disbursement from the account shall not exceed \$100,000.00 and all payments of any amount are to be authorized by the Board of Directors at a Regular or Special meeting of the Board of Directors.

SECTION 7. The Board of Directors may waive the \$100,000.00 limit as identified in SECTION 6, above, of any single disbursement at a Regular or Special meeting of the Board of Directors provided that such action shall be taken independently and as a part of a Staff Report to the Board specifically addressing the disbursement.

SECTION 8. This resolution shall take effect immediately upon its passage.

Purchase of the 4th UV module and programming upgrades for the Trojan Ultra Violet (UV) 3000 System

Recommended Action

Authorize the purchase of a TrojanUV3000 module from Trojan Technologies in the amount of \$131,164.33 including tax and delivery and new programming of the Trojan3000 PLC in the amount of \$17,970.00 and authorize the General Manager to execute all contract documents for a combined total amount of \$148,134.33.

Executive Summary

The District's Wastewater treatment process consists of a variety of methods that are utilized prior to effluent discharge. One of the key components of that process is the ultra violet disinfection, or UV. The UV system is the final treatment that removes harmful bacteria from the wastewater prior to its discharge into Old River.

The District utilizes Trojan Technologies UV Systems which are proprietary in nature resulting in a single source purchase. Currently, the District operates two (2) UV systems in two (2) separate channels. The older system consists of three (3) UV modules and is a TrojanUV3000 system. The newer and more recent installation is a TrojanUV3000PLUS and consists of four (4) modules.

Each secondary UV treatment system is a redundant system in that if one (1) module is down for maintenance, cleaning, or repairs, the remaining modules provide adequate treatment coverage. However, when an entire UV channel must be taken off-line for cleaning, the Trojan UV 3000 System does not have sufficient UV treatment to effectively comply with our NPDES permits when operating by itself. The addition of the 4th module resolves this situation and was recommended in the Master Plan Update. The programming changes are necessary to resolve discrepancies in UV dosing noted during the recently completed UV Bioassay testing.

This project was included in the Master Plan and the list of Capital Financed Projects and is consequently a budgeted item.

Earth Day 2013- Blue Star Memorial and Garden Project, Slifer Park

Recommended Action

Authorize staff to proceed with the Earth Day 2013 Blue Star Memorial Garden Project at Slifer Park and to coordinate with Contra Costa County for a project budget not to exceed \$15,000.00

Executive Summary

At the October 17, 2102 Board meeting, staff presented possible Earth Day Project options to the Board of Directors. The projects described included a demonstration garden and veteran's memorial. President Steele and Vice President Graves volunteered to meet with Staff and members of the local garden club to discuss the details and the focus of the project prior to bringing a recommendation to the full board for final consideration.

There were two working group meetings that took place – the first on October 25, 2012 and the second on October 28, 2012. Both meetings were held and discussions included options on site locations, project scope and scale, timelines, budgets and fundraising/donations. The working group better defined the details of the project and propose, as follows:

The District will work cooperatively with the Discovery Bay Garden Club to move forward with the Garden Clubs current Blue Star Memorial Byway Project. The Blue Star Memorial Project was started by the National Garden Club in 1945. Blue Star markers are placed on Highways or Byways and are a way of paying tribute to the US Armed Forces, and for service members serving their country during a time of military conflict or war. The Discovery Bay Garden Club has received approval from the National Garden Club to place a Blue Star By-Way marker within Discovery Bay. The club has already purchased its Bronze plaque, and they would like to place the marker into one of the local parks.

The opportunity to combine the Blue Star Memorial Project with our 2nd Annual Earth Day Garden Project seems appropriate. The site chosen by the working group is a 2,200 sq ft half-circle area located within Slifer Park. Although specific detailed plans have yet to be drafted, staff has prepared a preliminary budget that is expected to cover anticipated costs associated with completing the Blue Star Memorial and surrounding Garden Project. The budget includes demolition, soil preparation, irrigation modification, DG pathways, plantings, mulch, and of course, the memorial monument and bench. The Garden Club has pledged \$2,500.00 towards the project. It is not expected that project costs will exceed \$15,000.00.

Staff recommends that the Board approve the project and recommended project budget, with the understanding that: 1) Garden Club and TODBCSD Staff intend to offset all possible costs with donations, volunteer services and fundraising; and, 2) TODBSCD Staff will need to coordinate final approval with Contra Costa County Staff.

Acquisition of the Discovery Bay Athletic Club site and ongoing Facility Operational Considerations

Recommended Action

Discussion and Possible Action regarding the Discovery Bay Athletic Club and ongoing Operational Considerations

Executive Summary

As the Board is aware, the Town of Discovery Bay is in the middle of a three (3) party escrow to purchase a 10.24+/- acre parcel at the corner of Discovery Bay Boulevard and Willow Lake Road for a future Discovery Bay Community Center. The District owned parcel will be 7.385+/- acres while the remaining 2.8615 +/- acre parcel will be acquired by Delta Community Presbyterian Church for their future expansion needs. Escrow is tentatively scheduled to close in late December, 2012.

Staff has identified a number of ongoing operational issues related to the current club, and staff is seeking Board input and direction at this time.

After a number of site visits it is apparent that there are a variety of improvements (both small and big) that need to occur, including landscaping, painting, and some electrical work, to name just a few. There are also some areas that are on the eastern boundary of the site that will need to be fenced off for safety concerns. A building inspection has taken place and the inspection report is pending. That report will eventually become the impetus for many of the corrective actions that will need to be addressed.

Staff is in the process of reviewing the club's financial information, and while the revenues generated from membership are noteworthy, there are a number of questions that remain to be resolved pertaining to expenses. Staff hopes to be able to provide a more detailed financial outlook at the meeting.

Concurrently with the purchase transaction, staff is moving forward with plans to continue to operate the club in its present membership status. It will be necessary to contract the management of the operation to a qualified third party who will be responsible for all club operations. Staff has initiated that process and is developing a Request for Qualifications for the ongoing athletic club operation. Staff and the Community Center Committee believe that with modest improvements the club will again begin to attract new members. Once escrow has closed and club operations have been transitioned, additional community based programming on the site can then be contemplated.

Staff is seeking direction on ongoing operational matters associated with keeping the athletic club open into the foreseeable future until such time exists when it is necessary to close the facility and construct the new Community Center.

The business meeting was called to order at 6:34 p.m. by Chair Bette Boatmun. Following is a review of the meeting:

Chair Bette Boatmun, Contra Costa Water District (CCWD), opened the meeting and introductions were made around the room.

III. Approve November 10, 2011 Meeting Report

The meeting report of November 10, 2011 was approved by unanimous vote of the Governing Board.

IV. Treasurer's Report

Tim Coley, City of Antioch, reported there is a balance of \$4,433.53 in the ECWMA account as of May 23, 2012. The last expense was \$968.38 for the November 10, 2011 Dinner and Business Meeting. Chair Boatmun reiterated her statement from the last meeting requesting if members cannot make the meeting they let Ms. Jones know in a timely manner so that we are not paying for extra meals. She stated that those who responded that they were attending and did not show up will be billed for the cost of their meal.

Chair Boatman asked that everyone pass the master roster around and update their agency information as needed.

V. East Contra Costa County Integrated Regional Water Management Plan Update (funded under Proposition 84 Round 1 Planning Grant)

Chair Boatmun reported on the need to publicize the application for grant money and when money is received. The public should know when we apply for funding and that we are leveraging our agency funds with state grant funds. The information should be in our newsletters, public TV, newspaper, etc. You get more response when people know. They need to be reminded of the good work we are doing. She asked that Gary Darling, DDSD, get a group together to work on publicity.

- b. Round I Project Update DDSD, Pittsburg Recycled Water Pipeline Rehabilitation: Caroline Quinn, DDSD, provided a report.

VII. Proposition 84 Round 2 Planning Grant Update

Ms. Valmores provided a report on new projects.

VIII. Proposition 50 Modified Agreement – Final Project Reports

Ms. Valmores reported this is a \$12.5 million Grant and all projects have been completed to date and they are now making sure all paperwork has been submitted to the state.

- a. Antioch Recycled Water Project: Mr. Coley provided a report on the project which is now completed.
- b. Diablo Water District Well Utilization Project: Mike Yeraka, DWD, provided a report on this project that has been completed. All paperwork has been submitted and they are waiting for reimbursement of the \$700,000.
- c. Pittsburg Recycled Water Project: Walter Pease, City of Pittsburg, provided a report on the project that has been completed.
- d. Habitat Conservancy and Watershed Protection/Restoration Project: Ms. Fateman provided a report on two projects.
- e. Marsh Creek Fish Passage Improvement Project:

Mark Boucher, Contra Costa County, reported on the Fish Ladder project that was recently completed with Proposition 50 funding.

f. Mitigation Habitat for the AIP and Canal Improvement Projects: Mark Seedall, CCWD, provided a report.

Mr. Valmores reported that this group is one of the first Proposition 50 Grant recipients to have completed all projects. Chair Boatmun reiterated from her earlier statements that this is the type of information we want to put out to the public so they know what's happening with their money and to gain support of other projects.

IX. Update of Agency Rosters

Denise Cappucini Jones, DDSD, asked that all attendees review the Master Roster being circulated and make any necessary changes to it.

X. Agency Information Sharing – Reports on Water, Wastewater and Watershed Activities
Mark Boucher reported on Contra Costa Flood Control District's Proposition 1E funding request
for a project to receive water from upper sand creek basin on the south side of Antioch. The total
project cost is \$14 million, with \$2 million of it is from grant money as a result of the ECWMA.
Plans and specs are being completed to go to bid in December 2012, with construction planned for
next spring and fall.

Ms. Fateman reported that the Habitat Conservation Plan (HCP) has agreement with Fish and Wildlife to permit projects in East County. By working together, they're able to streamline permitting to be done in a quarter of the time. First project is a safety widening on Deer Valley Road. Chair Boatmun is very proud that the HCP operating so efficiently.

Ms. Quinn reported on DDSD's strategy of outreach to gain partner agencies to seek both state and federal funding. The Bay Area Recycled Water Coalition (BARWC) was started about five years ago and has grown from the original 6 to 15 agencies to coordinate efforts to secure federal funding through the Title 16 Program for recycled water projects. It is open to other agencies seeking to develop and expand recycled water. The Coalition has been very successful in seeking federal authorizations and appropriations under Title 16. They have received \$35 million in federal funding for the Bay Area for recycled water projects. Seven projects have been constructed and the balance of the agencies has received Project Planning funding. The Coalition does outreach annually and will be doing that soon if any other agencies are interested. Brochures were made available.

Ms. Valmores reported on the Proposition 1E Grant Program. CCWD received \$10 million for a segment of the unlined canal to build a mile of pipeline and a flood control structure.

Ms. Valmores reported on Proposition 84 rounds one and two outreach efforts for CCWD. The new, robust website will go live in about a week. CCWD is hosting the website and it is the method they will be using to collect project information.

Virgil Koehne, Town of Discovery Bay (DB), reported they recently completed 10-year water and wastewater master plans. Some community service deficiencies were noted in the plans and are being addressed. They want to have some projects shovel-ready in the event grant funding becomes available.

Mr. Koehne reported on the thermal biosolids system brought in from Germany six years ago to dry their sludge. It has been very successful, exceeding their expectations, and they are now building a third system.

Mr. Koehne reported on the wastewater treatment plant pilot program with a goal of keeping a biological process as long as they can. U.C. Berkeley students were originally brought in to do pilot testing to remove copper and aluminum, which worked out great, but now they're using the same cells with a different makeup to pilot test the removal of Pharmaceuticals. Recently, DB has been approached by Stanford students and he's tasked them with conducting a pilot test on desalination.

Ms. Naillon reported on the status of the Los Vaqueros Reservoir. It will be opened to the public on the north side on Saturday, July 14th. It will be free all day with activities for families.

XI. Adjournment

The Meeting was adjourned at 7:10 p.m. The next regular meeting will be <u>Thursday</u>, <u>November 8, 2012</u> at 5:30 p.m.
