#### A. ROLL CALL

- 2. Roll Call was taken, and all members were present.

#### C. DRAFT MINUTES TO BE APPROVED

Approve Water and Wastewater DRAFT Meeting Minutes of April 3, 2024.

Vice-Chair Porter made a Motion to Approve the April 3, 2024 Draft Meeting Minutes. Chair Graves seconded.

## D. UPDATES

Water and Wastewater Manager Aaron Goldsworthy gave both the Water and Wastewater Updates.

- 1. Wastewater Update.
  - Staff is asking for Stantec to make a change to the Town's NPDES permit.
  - Staff is working on Village 2 and 4 pump station rehabilitations.
- 2. Water Update.
  - Well 8 project bids are due May 21, 2024. There is a non-mandatory pre bid meeting on May 9, 2024. Project should take approximately 1.5 years to complete.
  - Willow Filter Project will continue week of May 13<sup>th</sup> with slight redesign. Expected to be complete mid-June.
  - Sand Point underwater crossing pipe upgrade plan is having some modifications due to easements.
  - Marlin Marina underwater crossing is being delayed. Staff is getting bids on a liner system that was
    originally thought to be a propriety item.
  - Reclamation District 800 cleaned the ditch in front of Newport development.

#### E. DISCUSSION

 Discussion and Possible Feedback Regarding the Mobile Modular Contract Proposal to Create Architectural and Engineering Plans for the Future District Office Building.

Presented by General Manager Dina Breitstein.

- Mobile Modular presented at the March 6, 2024, Water and Wastewater meeting. Option 4 (new office building next to Community Center) and Option 7a (replace building at existing District Office site) were discussed as possible sites for a modular building.
- At the following Board Meeting, it was recommended that the Community Center site was more desirable.
- On April 3, 2024, a quote was received from Mobile Modular which includes programming response phase services, schematic design phase services, design development services and construction documents phase services. Quote totaled \$451,900,000.
- Staff recommends bringing the option of the District Office at the Community Center property site (Option 4) to the full Board of Directors. This would negate all other options.

Committee agrees with recommending Option 4 to the full Board of Directors.

#### Public Comment:

- 1. The speaker favors including the Board Room in the new building. He also wants to ensure the façade looks good.
- Discussion and Possible Feedback Regarding Veolia North America's Third Amendment to the Water and Wastewater Operations and Maintenance Service Contract.

Presented by District Legal Counsel Andy Pinasco.

- Veolia contract has not been amended since 2016.
- Town assets have changed in the years since 2016.
- Veolia suggests amending the compensation structure.
- Compensation would have an annual increase of \$300,000.00
- Staff is still in negotiations with Veolia.
- Discuss Cancellation of the July 3, 2024 Water and Wastewater Committee Meeting.

Committee agrees with cancellation of the July 3, 2024 Water & Wastewater meeting.

#### **RECOMMENDED ACTION:**

Discuss and Provide Input to Staff Regarding the Well 8 Pump Station Bid Results for approval by the Board of Directors at the Jun 19, 2024, Board Meeting.

#### **EXECUTIVE SUMMARY:**

The Town opened bids for construction of the Well 8 Pump Station on May 30, 2024, and received four bids ranging from \$4,403,700 to \$5,070,343 as indicated on the attached. The engineer's estimate for the project was \$3,670,000.

The remaining costs to complete the project, including 10% for contingencies, total \$5,550,000, which is \$600,000 more than the \$4,950,000 in the current draft of the FY 24/25 budget. Staff will be recommending to the Board that the final FY 24/25 budget be increased to \$5,550,000.

The project scope includes installation of the well pump, pipelines, tanks and treatment facilities.

Staff is in the process of evaluating the bids and should be able to determine the lowest responsive bidder by the June 5, 2024, Water & Wastewater Committee meeting. Staff plans to recommend the award of bid to the Board of Directors at the June 19, 2024, meeting.

#### **Specific Committee Action:**

Discuss and Provide Input to Staff Regarding the Well 8 Pump Station Bid Results for approval by the Board of Directors at the Jun 19, 2024, Board Meeting.

#### **FISCAL IMPACT:**

\$4,403,700 plus \$440,370 as 10% contingency. Funds will be available in the FY 24/25 budget

The Board authorized construction of Well 8 at the May 17, 2023, Board Meeting.
