Agenda Title

Discussion and Possible Action Regarding Slogan "Live Where You Play in Discovery Bay".

Recommended Action

Authorize the General Manager to work with legal to pursue Town trademark rights to the slogan "Live Where You Play in Discovery Bay."

Staff's earliest known use of the tagline, "Live Where You Play at Discovery Bay" was in the early 1970s by Veronica Development Corporation in a brochure used during the release of Willow Lake/Cabrillo Bay homes. Since that time, there have been various iterations and variations of the slogan. Staff research cannot find where trademark ownership of any variation of the slogan has ever been tied to a specific entity. Over the years, the tagline of "Live Where You Play in Discovery Bay" has become enduringly linked with the Town of Discovery Bay CSD. To staff's research and knowledge, our CSD has never officially acquired the trademark or other legal right to the slogan. Staff presented this issue to the Internal Operations Committee at their special meeting on August 23, 2018.

The Internal Operations Committee recommended that legal investigate the process for acquiring trademark rights to the slogan "Live Where You Play in Discovery Bay" and to report back to the full Board for a decision on whether to proceed. Legal has provided an explanation of the process as follows:

The "Live Where You Play in Discovery Bay" slogan has a possible history and may have been used by Discovery Bay developers. Since trademark rights are "first in time of usage," then it is possible a developer that has used the slogan, and continues to use it in commerce, could object to our application with the USPTO. Other than that, other thoughts are of the 'typical' type:

- 1. We need to determine the type of use. This is a promotional/advertising concept for the CSD, but we would need to research the exact type and select from the USPTO Trademark ID Manual.
- 2. We would need to do a comprehensive trademark clearance search using our TradeMarkNow subscription. The cost charged by our firm for that search is \$300.
- 3. We would need to determine if the slogan is currently being used by Discovery Bay and obtain specimens of that use going back as far in time as possible. Photographs of newspaper ads, pamphlets, website promotions, billboards and the like need to be available.
- 4. The application process can be lengthy, but not necessarily expensive. If unopposed the time-line from application filing to issuance of the certificate of registration is about 18 months. Most of that time consists of the USPTO reviewing and acting on information we have provided in the application itself.


