1. Diffuser Project Update

Presented by Gregory Harris of Herwit Engineering.

- No missing or broken diffusers were uncovered during the diffuser inspection. There were 5 plugged diffusers noted. Plugged diffusers were partially cleared. Vac truck will be used for clearing the rest of the silt and snail shells.
- Isolation valve needs to be placed on the top of the levee per Rec 800 requirements. Shore side piping will need to be modified.

1. Discussion Regarding Authorizing Luhdorff & Scalmanini to Provide Design and Construction Engineering Services for Willow Water Treatment Plant Filter #1 Addition; and Authorizing the General Manager to Enter into a Purchase Contract with Loprest for a 2,200 GPM Filter Vessel.

Presented by Oscar Serrano with Luhdorff & Scalmanini.

- Luhdorff & Scalmanini reached out to various water treatment filter vendors. The lowest responsive quote was from Loprest at \$420,000.
- Lead time for the filter is 34-40 weeks. If purchased now, construction would not take place until fall of 2023 or early 2024.
- Total project cost is \$1.4 million which includes the Loprest filter, design and construction services, as well as contractor's installation costs plus contingencies.

Committee will recommend approving this expenditure at the Board of Directors meeting.
