#### Agenda Title

Review, Discussion and Possible Recommendation relating to the Mission Statement of the Future Community Center

#### **Recommended Action**

Forward recommendation to Town of Discovery Bay Community Services District Board of Directors to consider adoption of a Mission Statement for the future Community Center

#### **Executive Summary**

At the February 4, 2013 meeting of the Community Center Committee, staff presented a draft mission statement for Committee consideration. The Committee did not take any formal action on this item other than to seek additional information from staff on the possible development of a Mission Statement.

Mission Statements are often utilized by an organization to convey a sense of direction and describe their distinctive purpose. It is also important to describe how an organization is unique in its scope of operations and its services. Essentially, a Mission Statement conveys organizational purpose while providing motivation and general direction.

In the case of the Discovery Bay Community Center, staff recommends that a Mission Statement be adopted that can assist in promoting its message, describing its use, and setting its direction.

Staff has drafted a sample Mission Statement and is requesting committee review, input and possible recommendations. The draft statement reads: The mission of the Discovery Bay Community Center will be to provide a centralized location where community based programming is to be offered that will stimulate, educate and enrich the lives of people within Discovery Bay and surrounding communities and that is complemented by a system of parks, recreation areas and other facilities aimed to encourage recreational and leisure time activities.

It is also appropriate to more fully describe the functions, services offered, and the manner in which those services will be provided. For example, "The mission of the Discovery Bay Community Center will be to provide a centralized location where *fitness, aquatics, tennis, and* other community based programming is to be offered in a comfortable *and relaxing* environment that will stimulate, educate and enrich the lives of people within Discovery Bay and surrounding communities and that is complemented by a system of parks, recreation areas and other facilities aimed to encourage recreational and leisure time activities (*Italicized words added*).

The attached sample of Mission Statements from a variety of other Community Centers provides examples of mission statements that are used.

Review and discussion on Community Center temporary closure schedule

#### **Executive Summary**

On February 4th, 2013 the Discovery Bay Community Center Committee reviewed the proposed Operating and Capital Budget for the Community Center. The committee forwarded a recommendation for approval and on February 6th, 2013 the Town of Discovery Bay Board of Directors voted to adopt the recommended budget.

Staff has already begun to implement some of the operational items related to the budget; including hiring, purchase of computer and software, scheduling of repairs and coordination with various vendors. In order to properly proceed with some of the repair and sanitation items, staff is proposing to temporarily close the facility for two days. The temporary closure will allow time for removal of all equipment so that a thorough carpet cleaning can occur. As each piece of equipment is removed, it will be inventoried, sanitized and checked for any required maintenance. After the floors have been cleaned, equipment will be relocated into the facility with consideration of all safety concerns. Equipment not operating or repairable will be moved offsite and stored. Any other repair items that require temporary power or water shut offs will also be scheduled during the closure period.

The temporary closure is tentatively planned to begin at 9:00 a.m. on Thursday, February 21, 2013, and reopen Saturday morning at 7:00 a.m. This allows for users to attend their regular classes or workout schedules and to plan accordingly.

Discovery Bay Earth Day 2013 Festival and Volunteer Project

#### **Recommended Action**

#### **Executive Summary**

The Town of Discovery Bay will host its second annual Earth Day Volunteer Project and Family Festival on Saturday, April 20, 2013.

On February 6, 2013, the Board of Directors of the Town of Discovery Bay finalized the purchase and Operating Budget and Capital budgets for the Community Center through June 30, 2013. Concurrent with the planning of the Community Center's operational issues, staff has been working on coordinating plans for this year's Discovery Bay Earth Day Volunteer Project and Family Festival. With the purchase of the new facility, staff recommends holding all festivities at the Community Center. The center is large enough to accommodate any visitors and give the community an opportunity to see and learn about their new Community Center, and what services will be offered.

On November 7, 2012, staff presented a possible Earth Day project option to the Board of Directors. The Board authorized and approved a Blue Star Memorial Project to be installed cooperatively with the Discovery Bay Garden Club at Slifer Park. This project is currently moving forward, however, it does not afford the same volunteer opportunities that last year's event held. With over 200 volunteers in 2012, it is estimated that the Blue Star Memorial Project will only accommodate approximately 20 volunteers. As a secondary Earth Day Volunteer Project, and to go hand-in-hand with the Earth Day Festival at the Community Center, staff is recommending the installation and program development of a "Community Garden" in the empty lot located on the northwest boundary of the Community Center property line (behind the fire station).

Staff will be presenting budgets, project ideas and samples for review and discussion.
