### C. DRAFT MINUTES TO BE APPROVED

1. Approve July 7, 2021, Regular Water and Wastewater Committee DRAFT meeting minutes. Motion by Vice-Chair Porter to approve the Draft Minutes for July 7, 2021. Second by Chair Graves.

### D. PRESENTATIONS

1. Update on Diffuser and Denitrification Projects.

Water and Wastewater Manager Aaron Goldsworthy gave update on the postponement of the diffuser project. The project has been postponed for a year to get permits and to order parts due to design changes.

Chair Graves asked if there will be any fines associated with the extra time it will take.

Water and Wastewater Manager Aaron Goldsworthy advised there will not be any fines assessed since permits will continue to be updated.

Vice-Chair Porter asked if there will be any additional cost in the project.

Water and Wastewater Manager Aaron Goldsworthy advised there will not be any extra cost.

Water and Wastewater Manager Aaron Goldsworthy advised the Committee the denitrification project has begun. Parts needed have been ordered however they have been delayed due to COVID-19. District Water Engineer Gregory Harris advised contractors are also waiting on materials. Current permits can be extended if necessary and timeline for completion is still on track. All delays due to COVID-19 continue to be noted on

record.

Water and Wastewater Manager Aaron Goldsworthy advised there is a hole in a pump station at Plant No.1 which has been included in a contract for repairs.

### E. DISCUSSION ITEMS

1. Discussion Regarding the Installation of Two (2) Monitoring Wells at Cornell Park.

Water Engineer Justin Shobe explained to the Committee that for the Groundwater Sustainability Plan (GSP) the Town will need to install two wells for water monitoring. An assessment of viable locations determined the best location for the wells is at Cornell Park. Installation will be two wells of two inch diameter. One will be 15 feet in depth, the other will be 30 feet in depth. The cost of the well installations will be covered by grant money from Proposition 68.

General Manager Mike Davies notified the Committee that staff is looking for a recommendation to take this item to the Board of Directors at tonight's meeting.

Committee Chairs advised they will recommend approval of the well's location to the Board.

2. Discussion Regarding Water Capacity for Newport Pointe and Pantages Development Projects. Project Manager Mike Yeraka advised a capacity model was run by Luhdorff & Scalmanini Consulting Engineers to determine the ability to provide water to Newport Pointe and Pantages Development. Aging and unreliable equipment were considered. Current system water demand is less than the projected capacity determined by the model. Even with one large well taken offline, Project Manager Mike Yeraka advised he would still be comfortable with the capacity of the model. He estimated it will be about two years before Well 8 will come online.

Chair Graves recommended to move forward with work on Well 8 soon.


