F. DISCUSSION ITEMS

1. Discussion and Provide Feedback Regarding the Pre-purchase of Materials for Diffuser Project.

Discussion by Herwit Engineering, Gregory Harris.

- Staff Update will go to Board for approval, design documents are completed. Diffuser is an old river located near Contra Costa water facilities.
- Improvements include replacing the whole underwater feature of the Diffuser to be the same size 18" pipe, will add removable cap. Improvements will also include two check valves instead of one. Camera will be able to be used to see if there are any blockages. This is the most cost-effective option and maintainable.
- SOP will need to be developed by Veolia, Veolia will conduct tests prior to hiring divers.

According to Gregory Harris and Staff this project is budgeted and over budgeted due to inflation costs within the last year. Modifications have been made to reduce the costs. Pre-purchase of the valves need Board approval and be installed. All permits have been received from the State.

Vice-Chair Porter recommended getting the quotes finalized and sent to Board for approval to pre-purchase the duct valves. Chair Graves encouraged this project to move forward.
