1. Discussion Regarding Monitoring Well Project Delay Communications.

Assistant General Manager Dina Breitstein discussed a delay in the Monitoring Well Project. The project was scheduled to start last weekend, however the construction truck had mechanical issues. A new notice was sent to the affected community members notifying them of the delay. The Town's website was updated with this information. The construction has now started.

Chair Pease asked if anyone in the community has called with inquiries about the notice we sent out. Assistant General Manager Dina Breitstein responded that we have not received any calls regarding this notice.

Vice-Chair Gutow mentioned he lives in the affected area and his neighbors have approached him with questions, however he has not heard any disruptions coming from the jobsite.

2. Discussion Regarding Town Website Update.

Administrative Assistant Yesenia Monarrez updated the committee with the Town's analytic data. Documentation was provided which show the most frequented webpages and the average length of viewing time. Some webpages are temporary trends, such as News and Employment pages. These pages become an interest when there is new information available to the public. Comparison was done to analyze the last 90 days and the Year to Date numbers. Majority of topics remain consistently popular. Public was encouraged to continue checking todb.ca.com periodically for updates and the latest news affecting the community.

Vice-Chair Gutow asked if the mobile site can be modified to include more information that is available to only desktop users.

Administrative Assistant Yesenia Monarrez stated this has been mentioned to the website vendor and it is currently in the works.


