1. Approve DRAFT minutes of September 2, 2020 Water and Wastewater Committee meeting. Vice-Chair Bill Mayer made motion to approve minutes as noted on the record. Second by Chair Bill Pease.

### D. PRESENTATIONS

#### E. <u>DISCUSSION ITEMS</u>

1. Discussion Regarding Update on Well 8 Monitoring Well.

Water Engineer Justin Shobe gave update on Well 8 Monitoring Well. Well was drilled and soil samples were collected. Those samples have been sent to the lab for evaluation. Two monitoring wells were installed in the test hole. Water quality sampling has also been submitted to the lab. Results of the samples are starting to come in. Targeted capacity is as Town had envisioned for this well. Water quality issues have not been present. Comprehensive sampling will continue. Preliminary well design will be created as well as a letter to State Department of Drinking Water after reviewing testing results with the Town staff. State will be notified that this is a suitable site for a well and will be provided with a drinking water assessment surveying any potential contaminant activity. The next phase would be to bid for the well and work on getting the pump

station construction at the well site started.

Vice-Chair Mayer asked Water Engineer Justin Shobe how deep did the contractors have to dig.

Water Engineer Justin Shobe indicated the total drilled for the test hole was 500 feet. Monitoring wells were dug to about 320 feet.

Vice-Chair Mayer asked if residents complained about the noise level.

Water Engineer Justin Shobe said no community complaints were received.

Vice-Chair Mayer asked about a possible completion date.

Water Engineer Justin Shobe stated that approximate timeframe for the whole project would be about 18-24 months.

2. Discussion Regarding Update on the Urban Water Management Plan.

Water Engineer Justin Shobe provided update on the completion of the report. This report was last updated in 2015 and will reflect modernized information and new report requirements. Water conservation requirements will be addressed. All agencies will need a Water Shortage Contingency Plan and this will also be included as part of new requirements. Presently, Water Engineer Justin Shobe stated he is collecting information to complete this report and expects a preliminary draft to be available for review in a month. Timing is on tract to present the report to the Board for adoption in January 2021.

Vice-Chair Mayer requested a continuous update at each Water and Wastewater Committee Meeting regarding the Denitrification Project and the Well Project. Specifically, timeframe and expenses.
