The Board of Supervisors has requested County staff to inform the Municipal Advisory Councils of significant planning activities that may affect their communities. Enclosed please find a copy of a notice of the scoping meetings for the *Draft Environmental Impact Report of the Delta Plan*. These meetings are sponsored by the Delta Stewardship Council, which is a new state agency of appointed officials established earlier last year at part of the 2009 Delta Reform Act. This state law empowers the Delta Stewardship Council to develop a Delta Plan. The fundamental purpose of the Delta Plan will be to meet the coequal goals which are defined in the state water code as:

Achieve the two coequal goals of providing a more reliable water supply for California and protecting, restoring, and enhancing the Delta ecosystem. The coequal goals shall be achieved in a manner that protects and enhances the unique cultural, recreational, natural resource, and agricultural values of the Delta as an evolving place.

The primary planning area for the Delta Plan is the statutory Delta and Suisun Marsh. This includes the eastern shoreline area of Contra Costa County from the Alameda County line to the near Bay Point, and extending inland to include Byron, Discovery Bay, Bethel Island, Knightsen, and portions of Brentwood, Oakley, Antioch and Pittsburg.

The Delta Plan will define an integrated and legally enforceable set of policies, strategies, and actions that will serve, among other things, as a basis for future findings of consistency by state and local agencies with regard to certain actions within the Delta, and for subsequent evaluation of those findings by the Delta Stewardship Council on appeal, as provided by state law and regulation.

This department is monitoring preparation of the Delta Plan and will provide comments to the Delta Stewardship Council regarding the scope and content of the Environmental Impact Report. Those interested in Delta issues are encouraged to attend one of these scoping meetings. "Coequal goals" means the two goals of providing a more reliable water supply for California and protecting, restoring, and enhancing the Delta ecosystem. The coequal goals shall be achieved in a manner that protects and enhances the unique cultural, recreational, natural resource, and agricultural values of the Delta as an evolving place."

BACKGROUND

In November 2009, the California Legislature enacted the Sacramento-San Joaquin Delta Reform Act of 2009 (Act), which established the Delta Stewardship Council (Council) as an independent state agency. The Act required the Council to prepare, adopt, and commence implementation by January 1, 2012 a legally enforceable, long-term resources management plan for the Delta (referred to as the Delta Plan).

The Council will hold a series of CEQA scoping meetings during which input will be received on the environmental information that should be considered in the development of the Delta Plan and the associated CEQA Environmental Impact Report (EIR).

Following completion of the series of meetings, staff will review all CEQA scoping comments received (both oral comments made at the meetings and written comments received no later than January 28, 2011) and prepare a summary of comments for the Council. Staff will not prepare written responses to each individual comment received, but all comments will be included in the final CEQA administrative record for the Delta Plan.
