1. June 15, 2017 Special Water and Wastewater Standing Committee meeting minutes – Approved.

D. DISCUSSION ITEMS

1. Discussion related to replacing section of sewer line on Wayfarer Court.

District Engineer Harris and Project Manager Sadler – Provided an update regarding the Wayfarer sewer line related to the line not being an emergency (add to the CIP for some time next year) approximately 12 to 18 months out; more time to plan and start the bid process. There was discussion regarding the sewer line related to the condition of the pipe along with inspecting the sewer line. The Committee requested that the sewer line on Wayfarer Court update be added to the August 2, 2017 board meeting under Presentations.

2. Discussion related to the Willow Lake Water Treatment Plant PLC update.

District Water Engineer Shobe – Provided the details regarding the PLC update related to the programming being 95% complete and provide a write-up from Telstar with the details of what occurred. There was discussion regarding Station F, actual completion date of the project (May 31st) and cost. Veolia Staff will be handling the programming once Telstar is complete on the project.

3. Water Meter Installation Project update.

District Water Engineer Shobe – Provided a handout and the details regarding the Water Meter Project summary and map. There was discussion regarding the summary and map related to the Type 3 installations and the type of concreate, also regarding the creation of an account with EyeOnWater. The discussion continued regarding the manifold repair cost and angle meter stops. The Committee requested that the Water Meter Project update be added to the August 2, 2017 board meeting under Presentations. The project is within the Budget.
