Goal Setting

In an effort to maintain the course that the Board and Staff have been following over the past three years, Staff has identified the following Goals as important in continuing to sustain the momentum that the Town of Discovery Bay has been following.

- New Water & Wastewater 4 Year Rate Study
- > Vehicle and Equipment Storage Facility
- Establish Water conservation education programs in cooperation with Veolia Water, N.A.
- Make Significant progress on completing the Capital Infrastructure Project Program, including possible solar cell opportunities
- Finalize wireless connectivity (all facilities and plants)
 Increase use of www.todb.ca.gov with additional documents and information for the public to access
 Renew 5 Year NPDES

Parks, Landscape and Recreation

- Park Transfer Agreements to the BOD in Spring 2013 (Slifer and Regatta Parks)
- Work with Community Center Committee and BOD towards Community Center determination, and implementation of Rec Programs and related activities
- Landscape Contract to Bid early March for e/side of Town
 Staffing Needs (2.0 FTE, lea Landscape/Comm. Center)
- Highway 4 East Landscape Improvement project (replaced Clipper this FY due to Caltrans work on Hwy 4)
 Solar lighting and shade structures at Slifer Park
- All parks (incl. Park & Ride/walking path) require parking lot sealing
- Zone 61 Streetscape Project

Direction, Input, Suggestions, Recommendations, and Ideas (as identified by the BOD at the Workshop)

- Conduct a Board Study Session re: Community Center in approx 4-6 weeks.
- Recommended moving forward with converting one Cornell Park Tennis court for exclusive Pickle Ball Court use.
- 4. Evaluate potential Disc Golf Course.
- 5. Provide Splash Pad alternative site considerations to the Community Center Committee .
- 6. Develop Parks and Landscaping Master Plan RFP and coordinate efforts with the Parks and Landscape Subcommittee for an "allinclusive" proposal.
- 7. Mission/Vision/Values/Goals Provide input to staff and return to BOD with recommendations.
- 8. Improve website access use of RSS feeds, etc.
- Return to Board later this FY to discuss vehicle and equipment storage facility.
- 10. In lieu of proposal from BHI Consulting, possible one day Board Dynamics, Protocols and Practices session.

Overview of Proposal/Contract and Scope of Project:

The proposal reflects work for preparation for the session, conducting the 1-day session and a brief follow-up report. The consultant's effort and scope of work will be organized in the following manner.

Task Set (Tasks are listed chronologically)

- 1. Conduct a meeting with General Manager to review the approach and deliverables for the workshop. Request and review relevant doumentation regarding Board activity, actions, Board policies, and strategic or long-term planning, etc.
- 2. Attend two Board meetings (regular or Special called)
- 3. Conduct interviews with individual Board members to establish acquaintance with members, assess their individual goals and drivers relative to Board roles and service for use at the workshop.
- 4. Conduct a public Board workshop (anticipated for 4-6 hours) with the District Board. The workshop is <u>anticipated</u>, but is not limited) to cover the subjects such as:
 - the role of the Board,
 - proper Board protocols and activities,
 - Board interactions with the public, staff and each other
 - values practiced by Boards,
 - Board ethics in serving the public
 - making good policy
 - review of current goals and priorities
 - growth and optimal performance areas for Boards of Directors.
