

### D. PRESENTATIONS

### 1. Draft Water Shortage Contingency Plan

Water Engineer Justin Shobe presented the draft of the Water Shortage Contingency Plan. This plan is created to comply with requirements from the California Department of Water Resources. In the event of a water shortage, the Board of Directors will be required to initiate the plan and provide the Town with guidance and suggestions for solutions. Some of the possible solutions mentioned by Water Engineer Justin Shobe were adjustments to wells, observation of leaks, mandatory restrictions, bill inserts, public workshops. There are six water shortage levels from Mild to Catastrophic. Responses will vary depending on severity. Water shortages are determined by an Annual Water Supply and Demand Assessment. Water Engineer Justin Shobe discussed a schedule and deadlines for submitting this plan to the state. The Board can modify this Water Shortage Contingency Plan at any time. Water Engineer Justin Shobe requested to bring this item to the Board on February 17 for adoption.

Director Carolyn Graham asked how the six water shortage levels differ from the last drought we faced.

Water Engineer Justin Shobe stated there was a requirement to send in monthly reports to the state identifying measures the Town was taking to resolve the water shortage issue.

Vice President Kevin Graves asked if the regulations that Town of Discovery Bay had to comply with were the same state mandates that the entire state had to comply with and it did not necessarily apply to us because of our water supply.

Water Engineer Justin Shobe replied: Yes, that is correct.

Vice President Kevin Graves asked if the six water shortage levels presented today were the same as the ones previously presented.

Water Engineer Justin Shobe stated one level was added. Previously there were 5 levels.

Public comment regarding:

• Our ability to meet the demands of our consumers are more than adequate. Recalls water restrictions. Inquired if Town could contest with the state if restrictions were once again implemented. Stated that anyone is allowed to discuss this item since it is on the Agenda.

### E. MONTHLY WATER AND WASTEWATER REPORT- VEOLIA

1. Veolia Report – Month of December 2020.

Veolia Project Manager Gerry Lemus updated the Board with December 2020 operations. Advised of reports which have been submitted to the state as required. There was one Sanitary Sewer Overflow reported to the state and has not received a reply from that submission.

Vice President Kevin Graves asked if the Sanitary Sewer Overflow was the same one as previously discussed.

Veolia Project Manager Gerry Lemus confirmed it was the same situation.

Director Ashley Porter asked if there is a limitation of time for the state to respond.

Veolia Project Manager Gerry Lemus advised there is no time limit.

Public comment regarding:

None.

General Manager Mike Davies asked the Board to select a primary and secondary for each Regional Committee. Board was advised that attendance to these meetings is uncompensated and can be voted on prior to each meeting by the Board to make each meeting stipendiary.

Board and General Manager Mike Davies had a discussion regarding the necessity of attendance at the Regional Meetings listed. There were questions regarding the specifics of each meeting in order to understand its importance and the need to attend each one. Direction by the Board was given to bring this item before the Board in the future with descriptions of the meeting content and degree of recommendation

to attend.

General Manager Mike Davies advised the Board two members can attend these meetings voluntarily without creating an issue.

Legal Counsel Rod Attebery reminded the Board that Town of Discovery Bay does not control the meetings and historically meetings have been relevant to keep ourselves informed. Generally, these meetings are open to the public.

3. Discussion and Possible Action to Set the Date and Time of the 2021 Annual Board Workshop.

Annually the Town holds a meeting to update the Board on past, present and future plans for the Town of Discovery Bay. General Manager Mike Davies recommended this Annual Board Workshop be scheduled for Thursday, March 4, 2021 at 4:00 p.m.

President Bryon Gutow asked the Board if this date and time worked for everyone. All Board Members agreed on Thursday, March 4, 2021 at 4:00 p.m.

4. Discussion and Possible Action Regarding Landscaping on Discovery Bay Boulevard.

There is a refresh in process for the west side of Discovery Bay Blvd. Consideration was given to doing something more permanent such as widening walkways. It was determined that this would not be an economical and cost effective idea. Suggestion was made to instead allow the new Parks and Recreations Committee to present ideas for something more elegant than the refresh. This will require a pause in refreshing the west side of Discovery Bay Blvd.

President Bryon Gutow advised that in speaking to Reclamation 800, it was determined that exploring other options is not feasible.

General Manager Mike Davies advised that if a pause were taken, staff recommendation would be to work on islands on the south part of Discover Bay Blvd.

President Bryon Gutow stated he prefers to not take a pause and to continue with the work that has already been decided upon by the past committee.

Discussion was had by the Board and Parks and Landscape Manager Bill Engelman regarding landscape possibilities.

Public comment regarding:

Continuing with the landscaping upgrade of Discovery Bay Blvd.

General Manager Mike Davies advised Legal Counsel Rod Attebery a motion would not be necessary as it was decided to proceed with the last approved motion for this item.

Award Contract to McNabb Construction for the Installation of Ravenswood Park Play Structure.

Parks and Landscape Manager Bill Engelman discussed the replacement of the play structure at Ravenswood Park. Original budget was approved for \$98,853.00. McNabb Construction provided a bid for playground structure installation of \$48,888.00. Total budgeted for this project was \$173,000. The new total cost of this project is \$161,161.00. Staff requested approval allowing Town General Manager to be permitted to execute all contracts and necessary purchase orders for the installation of this playground equipment.

Vice President Kevin Graves asked if research had been done on this vendor.

Parks and Landscape Manager Bill Engelman stated that McNabb Construction has previously done work for Town of Discovery Bay.

Public comment regarding:

• The use of Zone 9 funds to maintain the playground structure.

Pursuant to Board Bylaws, Policy 002, Article IV, Section 2: "Board members shall be assigned to attend Regional Meetings.... Board members will have preference of committee selections in the following order: President and Vice-President, followed by the senior most next consecutive Board members.... This procedure shall be used to fill Primary and Alternate members to respective Regional Representation." By this formula, priority selection is as follows:

1. President Gutow 2. Vice-President Graves 3. Director Porter 4. Director Callahan 5. Director Graham

Pursuant to Article III, Section 2 of the Board Bylaws, "Director attendance at Regional Meetings shall only count as a compensated day of service when attendance at a Regional Meeting is specifically authorized in advance by the full Board." The Board may vote to do a blanket (for the full two-year term or less) authorization of attendance for any particular meeting date or all meetings.

### **Contra Costa County Aviation Advisory Committee**

The Aviation Advisory Committee (AAC) was established in 1977 to provide advice and recommendations to the Board of Supervisors on aviation issues related to the Contra Costa County Airports. The AAC works to advance aviation while giving those community members living and working near the Airports a chance to stay informed on Airport matters as well as voice their opinions and concerns. The AAC also provides a forum for vetting policy matters related to Buchanan Field and Byron Airports. Meetings are noticed and open to the public. Agendas:

### Contra Costa County Code Enforcement

The Contra Costa County Code Enforcement meetings take place at the County Supervisor's Office in Brentwood. In attendance are representatives from Byron, Bethel Island, Knightsen and Discovery Bay. County staff includes a member from County Health, County Code Enforcement, the Sheriff's Office (occasionally) and a representative of the Supervisor's office. Discussion involves reporting code violations, progress on past violations and enforcement issues. Meetings are not open to the public. Since most code violations are reported to staff, the Discovery Bay GM attends the meetings and follows up on enforcement. Agendas are prepared & sent to participants prior to the standing meeting dates. Meetings are scheduled for either the 4th or 5th Thursday of the month.

**Staff Recommendation**: The GM attends the meetings since most violations are reported to the main office. Board Member attendance is not necessary on a routine basis.

### Contra Costa Special Districts Association (CCSDA)

The purpose of CCSDA is to propose and advocate constructive means for the improvement and functioning of Independent Special Districts within Contra Costa County and to assist such Districts and their governing bodies to provide an effective and efficient government that will result in benefits to the public. CCSDA also cooperates with the California Special District Association in fulfilling its mission. CCSDA frequently conducts workshops, education seminars, and other programs of interest and benefit to its member districts. CCSDA is a non-profit unincorporated Association 501(C)6 entity. Its meetings are not open to the public, except by invitation. Agendas:

### East Contra Costa Fire Protection District (ECCFPD) Liaison:

ECCFPD provides fire and rescue services to East Contra Costa County, including Discovery Bay. ECCFPD is an Independent Special District that is governed by a 5-member Board of Directors. ECCFPD issues and policy decisions affect Discovery Bay. Discovery Bay Board Member attendance at meetings allows our Board to be up to date on matters affecting fire service and allows our Board Member a voice before ECCFPD policy decisions are made. ECCFPD meetings are noticed and open to the public. Agendas:

### **East County Water Management Association (ECWMA):**

The East Contra Costa County Integrated Regional Water Management Region (ECC-IRWM) is a distinct geographic region that covers 350 square miles. The IRWM is a collaborative effort to manage all aspects of water resources in a region. The East County Water Management Association (ECWMA) is a 12-agency group, including Discovery Bay CSD. Although staff attends and presents at the meetings, it is agency Board Members that have voting rights and hold office. The ECWMA covers all aspects of water management within the region: drinking water supply and quality, wastewater, recycled water, flood control and stormwater, and watershed and habitat management. ### **Local Agency Formation Commission (LAFCo) Liaison:**

LAFCo is the agency that must approve all Sphere of Influence (SOI) and jurisdictional boundary changes in Discovery Bay. LAFCo determines Discovery Bay's powers of water, wastewater, lighting, landscaping, parks and recreation. Residents who live in the P-6 Zone pay into a Sheriff's fund for law enforcement related services. A committee of local residents (appointed by the County Supervisor) meet with representatives of the Sheriff's Office to provide input on how P-6 monies are spent, and discuss concerns regarding public safety in the community. ### **Regional Transportation Agencies**

<u>State Route 4 Bypass Authority</u>: This 4-member Authority made up of Mayors from Antioch, Brentwood and Oakley, and Supervisor Burgis typically meets the 2<sup>nd</sup> Thursday of every month at Tri-Delta Transit. The meetings are noticed and open to the public. Staff checked online for Agendas and the last posted Agenda was in 2019. Staff does know that these meetings still take place and the Agenda is emailed to the GM.

Eastern Contra Costa Transit Authority (ECCTA): This was formed in 1977 as a Joint Powers Agency (JPA) consisting of the cities of Antioch, Brentwood, Pittsburg and the county of Contra Costa. Oakley incorporated as a city and joined in 1999. ECCTA is governed by an eleven-member board of directors composed of two appointed members from each of the mayors of Antioch, Brentwood, Oakley, and Pittsburg, two appointed members by the Contra Costa County Board of Supervisors, and one member at large. ECCTA operates fixed-route and paratransit service under the name "Tri Delta Transit" and contracts with a private company, First Transit, for the operation of buses. Bus routes end in Brentwood and do not reach Discovery Bay. The Board meets once a month on a Wednesday (typically the last Wednesday of the month) at 4:00PM, 801 Wilbur Ave, Antioch. ### **ARTICLE I**

### NAME

This unit of local government shall be known as the Town of Discovery Bay, a Community Services District, with powers and territorial boundaries as prescribed in Resolution No. 97/295 of the Board of Supervisors of Contra Costa County, State of California, dated June 10, 1997, and as provided by law.

### **ARTICLE II**

### **PURPOSE**

The purposes of the Town of Discovery Bay, as approved by the Local Agency Formation Commission and by law, are

- **A**. To Operate as a Community Services District and provide water distribution, wastewater connection and treatment; and parks, landscaping and recreation services to the residents of Discovery Bay.
- **B**. To provide for those exercise of those powers set forth in Government Code §61000 et seq. (Community Services District Law).
- C. To continue the advisory responsibilities of the Discovery Bay Municipal Advisory Council;
- **D**. To serve the residents of the Town of Discovery Bay, in the manner provided by law.

### **ARTICLE III**

### **BOARD OF DIRECTORS**

### Section 1. Board of Directors

The governing body of the District shall consist of five (5) elected Directors, each of whom shall serve for a term of four (4) year staggered terms. During elections every two (2) years, either two (2) or three (3) Directors are elected to serve to the District for the next four (4) years.

### Section 2. Compensation

The Board may authorize each Director to receive compensation of One Hundred and Fifteen Dollars (\$115.00) for each meeting of the Board attended, and One Hundred Fifteen Dollars (\$115.00) for each day's service not to exceed Six Hundred Ninety Dollars (\$690.00) per month as provided in Government Code §61047 and Chapter 2 commencing with Section 20200 of Division 10 of the Water Code.

Director participation in and completion of any mandatory training program for Directors required by California law shall be considered a single "day of service" approved for compensation only upon the Director's actual completion of each mandatory training program and the Director's delivery of a written report to the Board regarding the Director's participation in and completion of the mandatory training program at the next Board meeting following the Director's completion of the mandatory training program.

Director attendance at Regional Meetings shall only count as a compensated day of service when attendance at a Regional Meeting is specifically authorized in advance by the full Board.

Travel and such other necessary expenses actually incurred in performing District duties shall be reimbursed, and such reimbursement shall be in addition to the compensation specified herein consistent with the authorized Reimbursement and Travel Policy.

### Section 3. Vacancies

- **A.** Vacancies on the Board shall be filled in accordance with Government Code § 1780.
- **B.** Vacancies shall be deemed to exist as provided in Government Code § 1770.

### Section 4. Resignation

A Director may resign at any time by giving written notice to the Board, to the President, or to the Secretary of the Board. Any such resignation shall take effect at the date of the receipt of such notice or at any later time specified therein; and, unless otherwise specified therein, the acceptance of such resignation shall not be necessary to make it effective.

### ARTICLE IV

### **OFFICERS**

### **Section 1. Elected Officers**

The elected officers shall be chosen by the Board from among the five (5) members of the Board and shall consist of a President (who may be called "Chair") and a Vice-President (who may be called "Vice-Chair").

### Section 2. Terms and Responsibilities of Elected Officers

Elected Officers of the Board, as provided in Article IV, Sec. 1, shall be elected by the Board at the first meeting in January and shall serve for one (1) year, said term to commence upon election. All elected officers shall be eligible to serve successive terms, except that the President shall be eligible to serve not more than two (2) full successive terms as President.

Board members shall comply with all applicable local, state, and federal laws, including, but not limited to, the participation in and completion of any mandatory training program for Board members required by California law.

Board members may serve on Standing Committees, Ad Hoc Committees, and attend Regional Meetings as necessary.

Board members shall be assigned to attend Regional Meetings. Director attendance at Regional Meetings as a representative of the Board shall only be compensated as a day of service, when attendance at a specific Regional Meeting is approved in advance by the full Board.

Regional Representation is to be assigned based upon the position held by the Board member and the seniority of each member of the Board. Board members will have preference of committee selections in the following order: President and Vice-President, followed by the senior most next consecutive Board members. In the event seniority cannot be determined due to the date of assumption of office, the Board member with the highest vote count in their most recent election shall prevail as the senior member for purposes of this selection procedure. This procedure shall be used to fill Primary and Alternate members to respective Regional Representation. Board Members shall be assigned to the Regional Meetings for a two-year term.

The Board shall maintain five (5) advisory Standing Committees. Two members of the Board of Directors shall be assigned to each Standing Committee. The Standing Committees and their subject matter and responsibilities are as follows:

### 1. WATER AND WASTEWATER COMMITTEE

a. Provide guidance/policy recommendations regarding all water and wastewater operations and planning.

### 2. PARKS AND RECREATION COMMITTEE

a. Provide guidance/policy recommendations regarding community center operations/activities, parks and recreation activities and landscaping efforts.

### 3. FINANCE COMMITTEE

a. Provide guidance/policy recommendations regarding budgets, investments/debt and the Public Financing Authority.

### 4. COMMUNICATIONS COMMITTEE

a. Provide guidance/policy recommendations regarding all Town of Discovery Bay Community Services District external communications activities.

### 5. INTERNAL OPERATIONS COMMITTEE

 a. Provide guidance/policy recommendations regarding Town of Discovery Bay Community Services District personnel policies and general administration of the organization.

Each advisory Standing Committee shall meet within the boundaries of the Town of Discovery Bay Community Services District or at a Town of Discovery Bay Community Services District facility. Each Standing Committee shall establish its meeting schedule, which shall, at a minimum, meet at least quarterly. Said meetings shall be noticed pursuant to the Brown Act.

Board Standing Committees are to be assigned based upon the position held by the Board member and the seniority of each member of the Board. Board members will have preference of committee selections in the following order: President and Vice-President, followed by the senior most next consecutive Board members. In the event seniority cannot be determined due to the date of assumption of office, the Board member with the highest vote count in their most recent election shall prevail as the senior member for purposes of this selection procedure. This procedure shall be used to fill two appointees to each Standing Committee. Board Members shall serve on the Standing Committee for a two-year term. Board members may voluntarily trade committee assignments with another Board member by mutual consent.

The Board may establish Ad Hoc Committees that may become necessary from time to time to receive input from the public on a specific subject matter and limited in term, and formed by Resolution of the Board.

### A. General Responsibilities of the Board President

- 1. Shall preside at all meetings of the board and such other meetings approved by the Board, and have authority to call for short recesses during meetings unless a majority of the Directors by vote oppose a recess.
- **2.** Cooperatively work with the General Manager/Board Secretary and Staff on the preparation of CSD Meeting Agendas and its contents.
- **3.** Shall serve as official spokesperson for the Board.
- 4. Shall designate Directors or others to represent the Board at various meetings, hearings, and conferences, as confirmed by the Board. May co-sign all checks for warrants approved by the Board.
- **5.** Shall perform such other duties as necessary to carry out the work of the Board.
- **6.** Shall perform such duties as prescribed by law.

### B. <u>General Responsibilities of the Vice-President</u>

1. Shall serve in the absence of the President.

### C. Senior Most Board Member

- 1. Shall serve in the absence of the President and the Vice-President.
- 2. In the event seniority cannot be determined due to the date of assumption of office, the Board member with the highest vote count in their most recent election shall prevail as the senior member for purposes of this selection procedure.

### **ARTICLE V**

### **APPOINTED OFFICERS**

### **Section 1. Appointed Officers**

- A. The appointed officers of the District shall be General Manager, and a Secretary, who may be the same person, but neither of whom shall be a Director. The duties of the appointed officers shall be as specified in law, and as directed by the Board.
- B. Pursuant to Government Code §61050(b), the treasurer of the County of Contra Costa shall serve as the District Treasurer, and shall be the depositary and have the custody of all of the district's money except those accounts that are authorized under the Community Services District laws and/or in effect prior to January 1, 2006.

The Board may appoint such other officers as it deems necessary.

### Section 2. General Responsibilities of the General Manager

- **A.** Appraise and evaluate the effects of the Board policies and the manner of their execution, and the efficiency of District personnel in terms of services rendered to the people of the District.
- **B.** Provide leadership to staff in identifying District needs, establishing priorities and determining the objectives, which will achieve the established goals of the District.
- **C.** Encourage and assist staff in the performance of their duties and encourage their professional growth.
- **D.** Ensure evaluation of personnel under his/her direction.
- **E.** Interpret and publicize the programs and services of the District for and to the public.
- **F.** Provide financial oversight of the District and Contra Costa County pursuant to funds on deposit at that agency.
- **G.** Lead the District management team in the preparation of the budget, control of expenditures, inventory control, program planning, changing priorities and public relations.
- **H.** Perform the function of the District's Public Information Officer.
- **I.** Participate in community activities.

- **J.** Continue a program of professional development to assure and enhance staff's professional growth.
- **K.** Keep the Board informed of all communications affecting the District.

### Section 3. General Responsibilities of the Secretary of the Board

- **A.** Certify official documents and letters as required.
- **B.** Maintain the official files and records of the Board.
- **C.** Prepare the agenda for the Board meetings.
- **D.** Prepare and distribute minutes of the meeting of the Board.
- **E.** Maintain historical record and newspaper articles.
- **F.** Post agendas, minutes, public notices and proposed action documents as required by Board and government regulations.

### **ARTICLE VI**

### **MEETINGS**

### **Section 1. Regular and Special Meetings**

- A. The Board shall hold a regular meeting on the first (1st) and third (3rd) Wednesdays of each month, at the District Office located at 1800 Willow Lake Road, Discovery Bay, California 94505. Such regular meetings shall be for considering reports of the affairs of the District and for transacting such other business as may be properly brought before the meeting. Such meetings may be altered as to date, time and place, as provided for in a Resolution adopted by the Board.
- **B.** Special meetings may be called in accordance with the California Ralph M. Brown Act of 1953, as amended (hereafter Brown Act).

All meetings shall be conducted in accordance with the Brown Act.

### Section 2. Quorum

The Board shall be empowered to conduct the business of the District whenever there is present at a properly called meeting, a quorum, as defined as comprising a majority of the existing Directors; normally three (3); except as otherwise provided by law. Pursuant to Government Code §61045, the affirmative votes of three (3) members of the Board are required for action to be taken.

### Section 3. Voting

- **A.** Voting shall only be conducted at proper noticed meeting where a quorum has been established and members are physically present.
- **B.** Voting shall be by voice, show of hands, or roll call vote.
- **C.** Any vote that is other than unanimous shall be recorded by name of the voting member and whether the member voted "AYE", "NO" or "ABSTAIN".

### **Section 4. Notice of Regular and Special Meetings**

- **A.** Notices of Regular Meetings shall be pursuant to the Brown Act. Such notices shall specify the place, the day, and the hour of the meeting and accompanying the notice shall be a copy of the agenda for that meeting.
- **B.** Notices of Special Meetings shall be pursuant to the Brown Act. In the case of special meetings, the notice, written or by telephone, shall specify the specific nature of the business to be transacted.

### **ARTICLE VII**

### **PAYMENTS, CONTRACTS, AND REPORTS**

### Section 1. Payments

All checks, warrants, drafts, or other orders for payment of money, notes, or other evidences of indebtedness issued in the name of, or payable to, the District, shall be signed or endorsed by at least two of the District officials listed below:

- General Manager
- Assistant General Manager
- Finance Manager
- Member of the District Board of Directors

### **Section 2. Contracts**

The Board, except as in the Bylaws otherwise provided, may authorize any officer or officers, agent or agents, to enter into any contract or execute any instrument in the name of, and on behalf of, the District. Such authority may be general or confined to specific instances. Unless so authorized by the Board, no officer, agent, or employee shall have any power or authority to bind the District by any contract or engagement, to pledge its credit, or to render it liable for any purpose or to any amount.

### Section 3. Reports

The Board shall prepare and cause to be sent an annual water quality report to the residents of the District.

### **ARTICLE VIII**

### **PARLIAMENTARY AUTHORITY**

Rosenberg's Rules of Order, current edition or such other authority as may be subsequently adopted by resolution of the Board is to apply to all questions of procedure and parliamentary law not specified in these Bylaws or otherwise by law. All motions made at Board meetings shall require a second to the motion prior to the Directors voting. The President of the Board may unilaterally call for a recess at any time during a Regular or Special Meeting of the Board. The Board President may unilaterally adjourn the meeting unless a majority of the Board votes to continue the meeting.

### **ARTICLE IX**

### **AMENDMENTS**

The Bylaws may be repealed or amended, or new Bylaws may be proposed, by resolution and the affirmative vote of at least three (3) members of the Board at any regular meeting of the Board, provided notice of such proposal shall be in compliance with the Brown Act, as amended.

### Agenda Title:

- 1) Adopt Resolution No. 2021- 01 advocating for Contra Costa County to obligate a fixed percentage of Measure X funds to ECCFPD in order to fully operate three additional fire stations to enhance fire service response; and
- 2) Adopt Resolution No. 2021-02 supporting the feasibility assessment of a consolidation effort with ConFire.

### **Executive Summary**

As is widely known, there is a well-documented public safety emergency in the East Contra Cost Fire Protection District ("ECFPD") service area due to insufficient funding to expand personnel, stations, and equipment necessary to adequately protect the community. Adequate fire protection services is of great importance to not only the residents of Discovery Bay, but to the Town's water and wastewater facilities, landscaping, parks and recreation areas as well.

### <u>Measure</u> X

The County Board of Supervisors submitted Measure X, a half-cent sales tax increase, to the voters at an election held on November 3, 2020, and it passed with 58.45% of the vote. For 20 years, Measure X is expected to annually generate an estimated \$81 million in new County general fund revenues that the Board of Supervisors can allocate to address a wide array of community needs.

Addressing the fire funding deficiencies of ECCFPD is a top priority for ECCFPD, and on September 14, 2020, the ECCFPD board passed a resolution of support for Measure X, and noted that if it passes,

"the Board of Directors advises and asks the County Board of Supervisors to expeditiously dedicate a fixed percentage of the proceeds of Measure X, at a level that is significant with respect to the need for three additional fire stations in the District's service area, to benefit the residents of East County through improved levels of fire and emergency medical response services to be provided by the District."

### Consolidation with Contra Costa County Fire Protection District ("ConFire")

ECCFPD is now working on a more detailed assessment of the consolidation opportunity with ConFire and expects a final report by July 2021. If the ECCFPD Board moves forward, consolidation hearings at LAFCo would occur, and if approved, consolidation could be implemented starting early 2022.

Given the great importance that the Town of Discovery Bay CSD has placed on fire and emergency services, staff is recommending that Board adopt Resolutions No. 2021-01 and No. 2021-02.

**WHEREAS**, the East Contra Costa Fire Protection District ("ECCFPD") provides emergency medical response, firefighting, fire prevention, hazardous waste response, and other services relating to the protection of lives and property; and

**WHEREAS**, during the time ECCFPD has existed in its service area, including the Town of Discovery Bay, it has seen population growth, and the costs associated with ECCFPD services have exceeded increases in funding, so that ECCFPD is unable to adequately respond to the community's emergency medical and fire protection needs; and

**WHEREAS**, the resulting public safety emergency is well-documented, such that ECCFPD does not have sufficient funding to pay for the personnel, stations, and equipment necessary to adequately protect the community; and

**WHEREAS**, Discovery Bay and the region expect growth to continue, increasing the ECCFPD service area population to nearly 200,000 by the year 2040, which will generate even greater need and demand; and increase the pressure on the severely under-funded ECCFPD District; and

**WHEREAS**, the County Board of Supervisors submitted a half-cent sales tax measure to the voters at an election held on November 3, 2020; and

**WHEREAS**, as passed, the measure ("Measure X") is expected, for 20 years, to annually generate, an estimated \$81 million in new County general fund revenues that the Board of Supervisors can allocate to address a wide array of community needs; and

**WHEREAS**, Measure X revenues are expected to support essential County services, such as fire and emergency medical response services and other crucial safety-net services, some of which are provided directly by County agencies and some of which are provided by special-purpose agencies such as ECCFPD.

### NOW, THEREFORE, THE BOARD OF DIRECTORS OF THE TOWN OF DISCOVERY BAY COMMUNITY SERVICES DISTRICT DOES HEREBY RESOLVE AS FOLLOWS:

- SECTION 1. Request that the County Board of Supervisors dedicate a fixed percentage of the proceeds of Measure X, sufficient to provide for three additional fire stations in the ECCFPD service area, to benefit the residents of Discovery Bay and East Contra Costa County.
- SECTION 2. That this action is effective immediately.
- SECTION 3. The Board Secretary shall certify the adoption of this Resolution.

**WHEREAS**, the East Contra Costa Fire Protection District ("ECCFPD") provides emergency medical response, firefighting, fire prevention, hazardous waste response, and other services relating to the protection of lives and property; and

**WHEREAS**, ECCFPD serves 128,000 residents throughout 249-square miles in eastern Contra Costa County, including the Town of Discovery Bay; and

**WHEREAS**, ECCFPD was formed by the County Board of Supervisors in September, 2002, by combining the three small fire districts of Bethel Island, East Diablo, and Oakley; and

**WHEREAS**, during the time ECCFPD has existed in its service area, including the Town of Discovery Bay, it has seen population growth, and the costs associated with ECCFPD services have exceeded increases in funding, so that ECCFPD is unable to adequately respond to the community's emergency medical and fire protection needs; and

**WHEREAS**, the resulting public safety emergency is well-documented such that ECCFPD does not have sufficient funding to pay for the personnel, stations, and equipment needed to adequately protect the community; and

**WHEREAS**, Discovery Bay and the region expect growth to continue, increasing the ECCFPD service area population to nearly 200,000 by the year 2040, which will generate even greater need and demand; and increase the pressure on the severely under-funded ECCFPD District; and

**WHEREAS**, the Contra Costa County Fire Protection District ("ConFire") is an agency of Contra Costa County providing services similar to those provided by ECCFPD, to other geographic regions of Contra Costa County; and

**WHEREAS**, together ECCFPD and ConFire have begun to discuss and explore consolidation/annexation, with results of a feasibility study expected this summer.

### NOW, THEREFORE, THE BOARD OF DIRECTORS OF THE TOWN OF DISCOVERY BAY COMMUNITY SERVICES DISTRICT DOES HEREBY RESOLVE AS FOLLOWS:

- SECTION 1. Support for the feasibility assessment of a consolidation effort between East Contra Costa Fire Protection District and the Contra Costa County Fire Protection District, so that the residents of Discovery Bay and Eastern Contra Costa County are provided a level of emergency medical and fire response services that better address the region's needs.
- SECTION 2. That this action is effective immediately.
- SECTION 3. The Board Secretary shall certify the adoption of this Resolution.

### **Agenda Title**

Discussion and Possible Action Regarding Specified Board Member Training Qualifying as a Compensable "Day of Service."

### Recommended Action

Authorize Members of the Board of Directors to participate and complete those training programs necessary to qualify for the District of Distinction, Transparency Certificate of Excellence, and SDRMA Credit Incentive Program. Upon Board Member delivery of a written report to the Board of completing the training, the Member may be permitted a compensable "day of service."

### **Executive Summary**

Pursuant to Government Code § 61047 the Board of Directors may provide by resolution or ordinance, that Board Members may be compensated for up to six days of service a month and that compensation is limited to one hundred dollars (\$100) a day. The one hundred dollars (\$100) a day limit may be increased, if the increase is established by ordinance, but the actual days of compensation may not be increased to more than six days. Board Ordinance No. 23 increased the compensation amount to one hundred fifteen dollars (\$115) a day, with a limit of six days of service a month.

Government Code § 61047(e)(5) a "day of service" includes a Director's participation in a training program on a topic that is directly related to the Town, if the Board previously approved the Board Member's participation at a board meeting and the Board Member provides a written report regarding the Board Member's participation at the next board meeting, immediately following the training. As the current law exists, there are not additional requirements for the content of written reports. Therefore, any written document regarding the Board Member's participation in the training, including but not limited to a certificate of completion will meet the requirements of a written report.

Pursuant to Board Policy No. 002, Article III, Section 2: "Director participation and completion of any mandatory training program for Directors required by California law shall be considered a single 'day of service' approved for compensation only upon the Director's actual completion of each mandatory training program and the Director's delivery of a written report to the Board regarding the Director's participation in and completion of the mandatory training program at the next Board meeting following the Director's Completion of the mandatory training program."

The only training programs required by California law are Ethics Training (AB1234) and Anti-Harassment Training (SB1343/AB1825). When a Board Member participates in one of the aforementioned state-mandated training programs, Board Policy No. 002 provides the Board's prior approval, as required by California law. Therefore, the Board Member is eligible for compensation after the Board Member submits a written report to the Board at the meeting following the training.

There are additional training courses that are not required by California law; specifically, Members of the Board must successfully complete specified training for the Town to qualify for District of Distriction, Transparency Certificate of Excellence, and to receive Special District Risk Management Association (SDRMA) Credit Incentive Program points. The Town is currently at a Platinum Level District of Distinction. Out of over 3,200 Special Districts in the state, only 12 are Platinum Level. Holding/retaining these recognitions are important and can result in insurance cost savings. The following is a list of specified courses that each Board Member must complete to qualify:

- Brown Act Principles, Traps, and Avoiding Unintentional Violations
- Board Member Best Practices
- o Special District Leadership Academy (SDLA) OR

- SDLA Module 1 Governance Foundations
- SDLA Module 2 Setting Direction/Community Leadership
- SDLA Module 3 Board's Role in Human Resources
- SDLA Module 4 Board's Role in Finance and Fiscal Accountability

Pursuant to Government Code § 61047(e)(5), the Board may previously authorize a Board Member's presence at a training program only on a topic directly related to the Town. Board Policy No. 002, Article II identifies one of the purposes of the Town is to "Operate as a Community Services District and provide water distribution, wastewater connection and treatment; and parks, landscaping and recreation services to the residents of Discovery Bay."

The aforementioned courses directly relate to operating a Community Service District by educating Board Members on the best practices in public agencies and providing savings for insurance costs. As long as, the prior approval and written report requirements are satisfied, the Board Members may be permitted a "day of service" for taking the aforementioned training courses. If a Board Member fails to obtain prior approval or submit a written report at the next board meeting immediately following the training, the aforementioned courses cannot be a "day of service," in accordance with Government Code § 16407.

Since the aforementioned courses are training programs to obtain good governance recognition and insurance cost savings which are topics directly related to the Town of Discovery Bay, staff recommends that the Board authorize that Board Member participation and completion of each course constitute a compensable single "day of service."
